Consent Form

Information for parents/carers

South Hants Lawn Tennis Club aims to provide a safe and enjoyable experience for every child or young person. To help us do this, please note the following important information:

- We recognise the need to ensure the welfare and safety of all children.
- We have written a policy statement which sets out how photographs and videos of children involved in our activities should be taken and shared. A copy of this is available from South Hants Welfare Officer John Cooke/A physical copy at the club/or on our website
- We will take all steps to ensure images of children are used solely for the purposes they are intended. If you become aware that these images are being used inappropriately you should inform John Cooke immediately.
- We will not take or share photographs, video or other images of children and young people without the consent of the children involved and their parents or carers. This agreement fits with our overarching online safety policy.
